#### REPORT OF VOTING RESULTS PURSUANT TO SECTION 11.3 OF NATIONAL INSTRUMENT 51-102 CONTINUOUS DISCLOSURE OBLIGATIONS ("NI 51-102")

Following the Annual and Special Virtual Meeting of Unitholders of Cominar Real Estate Investment Trust ("Cominar") held on May 13, 2020 (the "Meeting"), and in accordance with section 11.3 of NI 51-102, we hereby advise you of the voting results obtained at the Meeting. Each of the following questions is detailed in the Management Proxy Circular dated March 31, 2020.

# 1. <u>Appointment of PricewaterhouseCoopers LLP as the Independent</u> <u>Auditor</u>
